PRIVACY CONSENT

A. Consent of Individual Applicant

In connection with my application and any subsequent applications to any of the financiers described in the Schedule (**Financier**) for credit, I acknowledge that the Financier will collect personal information about me (which may include "sensitive information" as defined in the Privacy Act 2001 (Cwth)(**Privacy Act**)), and that such information will be used to help the Financier assess this and subsequent applications, and if my applications are approved, for the subsequent administration of the credit facilities. I consent to the Financier collecting, using and disclosing my personal information for these purposes, and acknowledge that without this information, the Financier may be unable to process or accept my applications, or to operate or administer the credit facility.

I consent to the Financier and its related companies using or disclosing my personal information for;

- Performing administrative tasks and managing business operations, providing services to me in relation to credit facilities (if granted) or other products or services, and telling me about its products, services or other organisations;

I agree to the transfer of my personal information by the Financier and its related companies to organisations overseas for use in connection with any of the purposes authorised by this consent or the Privacy Act.

If and to the extent that the Financier does so in a manner and for purposes that conform with the Privacy Act;

- I agree to the Financier obtaining information about my commercial activities and commercial credit worthiness from a business which provides information about the commercial credit worthiness of persons, and to the Financier using that information in assessing these applications, assessing future changes to the approved limits and reviewing such limits;
- I acknowledge and consent that credit information may be given to a credit reporting agency;
- I/we acknowledge that the Privacy Act allows a credit provider which the introducer/broker may approach in arranging my/our finance, to give a credit reporting agency certain personal information about my/our applications for finance.

The information which may be given to an agency includes such permitted particulars about me/us which allow me/us to be identified;

- The fact that I/we have applied for finance and the amount; The fact that the credit provider is a current credit provider to me/us;
 - Payments which become overdue more than 60 days, and for which collection action has commenced; That payments are no longer overdue;
 - Cheques drawn by me/us for an amount not less than \$100, which have been dishonoured more than once;
 - That in the opinion of the above-named credit provider, I/we have committed a serious credit infringement;
 - Information as to court judgements against me.
- I agree to the Financier giving to and receiving from any credit provider named in the application, and any credit provider named in a credit report issued by a credit reporting agency, information about my credit arrangements, provided that the information is given or received to assess an application for credit made to the recipient credit provider, to assess my credit worthiness, to assess future changes to approved limits or in the review of such limits;
 - I agree to the Financier obtaining a credit report containing personal information about me from a credit reporting agency, using that report or any information derived from the report in assessing the application, assessing future changes to approved limits or in reviewing such limits, or if relevant, collecting overdue payments in respect of credit provided to me, and for any other purposes permitted under the Privacy Act (including where I am to provide a guarantee or other support in connection with the credit facility, to assess whether to accept me as a guarantor or whether to accept that support); and
 - I authorise a trade insurer in relation to my application (where it is for commercial credit) to obtain a credit report to assess whether to insure or assess the risk of insuring the Financier, and where I am the applicant for credit, to assess the risk of default by me on the credit provided.
 - I acknowledge that the bank of financier may pay a commission to the broker as a result of any banking services offered to me by the bank of financier.
 - I consent to the bank or financier disclosing ongoing information in relation to my banking services to the broker
